This high-level Manager will be partnering with the Regional Director of Corporate Compliance from the Dean Clinic, in the implementation and facilitation of ongoing CRP and HIPAA programs for all three SSMHCW hospitals in Madison, Janesville and Baraboo, Wisconsin, along with two skilled nursing facilities.

This position ensures fulfillment of the corporate responsibility, HIPAA and compliance-related statutory, regulatory and contractual obligations to ensure that the organizations exceed their objectives effectively.

#### Some of the essential objectives include:

- Serving as primary contact and assisting in day-to-day operations of the CRP and privacy programs for SSM Health Care of Wisconsin's three hospitals and two skilled nursing facilities.
- Assuring privacy and risk assessments, fraud and abuse, billing, audits and onsite monitoring is performed consistent with organization objectives.
- Training and consulting with entity presidents & departments to establish methods of improving efficiency and internal controls while reducing vulnerability to fraud, waste and abuse.
- Providing continued analysis, technical expertise and knowledge transmission of compliance requirements and keeping with evolving federal requirements and other contractual obligations.
- Assisting in the development and execution of training programs that focus on elements of CRP and HIPAA.

The ideal professional will have a Bachelor's Degree and a minimum of five years' progressive experience in <u>hospital</u> compliance and privacy auditing. Training and program implementation experience is also strongly preferred.

Exceptionally strong critical thinking, strategic analysis, communication skills, including public speaking and the ability to analyze complex problems, along with the advanced knowledge of Compliance, HIPAA and state laws is equally important.

The Dean Clinic is one of the largest integrated healthcare delivery systems in the country. Dean has been a physician-owned and physician-governed organization since its inception in 1904. Physician shareholders play a key role in leadership and work with professional management to further the mission of improving health in the community. Ninety-five percent of Dean is owned by physician-shareholders, with the remaining five percent owned by SSM Heatlh Care.

Headquartered in Madison, Wisconsin, Dean provides:

- Medical and health services through a network of Dean and SSM St. Mary's/Dean owned clinics throughout Southern Wisconsin.
- > Health insurance services through Dean Health Plan.
- Ancillary Health Services, including Dean Pharmacies, Davis Duehr Dean Optical, Essentials Skin Care Center, Aesthetic Surgery Center, Dean Therapy Services, Diabetes Education, Dean & St. Mary's Health Works, Dean on Call 24-hour nurse line, and full service laboratories and medical imaging services.
- > Clinical research and education through Dean Foundation.

Dean Clinic and St. Mary's Hospital own and manage more than 20 primary care clinics, with approximately 600 physicians. They also jointly own and operate the Surgery and Care Center in Madison, Riverview Surgery Center in Janesville, and Davis Duehr Surgery Center in Madison. St. Mary's is also affiliated with the University of Wisconsin School of Medicine three-year family practice residency program.

# This high level compliance manager position reports directly to the Dean Clinic, but responsibilities also include the following three SSMHCW hospitals.

These hospitals and SNFs are part of the St. Louis-based SSM Health Care, sponsored by the Franciscan Sisters of Mary. SSM Health Care owns, manages and is affiliated with hospitals and nursing homes in four states: Wisconsin, Illinois, Missouri and Oklahoma. The system has about 22,000 employees and 5,800 physicians who cared for more than 2 million people in 2009.

#### A summary of the three hospitals follows:

**St. Mary's Madison Hospital** is a not-for-profit tertiary referral hospital that offers a full range of inpatient and outpatient treatment and diagnostic services in primary care and nearly all specialties. The campus includes an outpatient surgery center, and an employee child care center. St. Mary's also operates an off-site adult day health center, is part-owner of a home health care organization, and is affiliated with the St. Mary's Care Center (skilled nursing facility) on Madison's southwest side. St. Mary's is the only hospital in the region to earn the prestigious Magnet Recognition for Excellence in Nursing from the American Nurses Credentialing Center of the ANA. Only three hospitals in the nation share this coveted honor. St. Mary's has a \$814.9 million gross patient service revenue and serves 18 counties in south-central Wisconsin with its 2,700 employees, 482 physicians and 440 licensed beds.

**St. Mary's Janesville Hospital**, which opened on January 9, 2012, is a 50-bed facility serving residents of Rock County and the surrounding areas. They will offer a full range of inpatient and outpatient treatment and diagnostic services in primary care and a wide range of specialties.

**St. Clare Hospital** in Baraboo, Wisconsin, is a leader in rural health care in south central Wisconsin, with more than 100 physicians serving the consulting medical staff. St. Clare offers acute care services and a wide range of other services, including chemical dependency treatment and hemodialysis.
